RESOLUTION TO APPROVE THE ARTICLES OF INCORPORATION OF THE INGHAM COUNTY LAND BANK FAST TRACK AUTHORITY AND AUTHORIZE THE CHAIRPERSON TO SIGN ARTICLES OF INCORPORATION

RESOLUTION #05-01

WHEREAS, the Land Bank Fast Track Act, 2003 PA 258, being MCL 124.751 et seq., ("the Act") establishes the State Land Bank Fast Track Authority which, among other things, has for

its purpose the assembly and clearance of title to tax reverted property in a coordinated manner; and

WHEREAS, the Act allows a foreclosing governmental unit, such as the Ingham County Treasurer, to enter into an intergovernmental agreement with the State Land Bank Fast Track Authority providing for the exercise of the powers, duties, functions, and responsibilities of an authority under the Act, and for the creation of a County Land Bank Fast Track Authority (the "Authority") to exercise those functions; and

WHEREAS, there exist in Michigan and Ingham County a continuing need to strengthen and revitalize the economy and it is in the best interest of the State of Michigan, Ingham County, and local units of government to strategically manage tax reverted and other property to foster the development of that property and to promote economic growth in the State of Michigan, Ingham County, and local units of government; and

WHEREAS, the Ingham County Treasurer, with Ingham County Board of Commissioners approval, has entered into such an intergovernmental agreement under the Act, with an effective date of October 21, 2005; and

WHEREAS, the County Board of Commissioners has appointed a Board of Directors consisting of five members (terms beginning November 1, 2005), including the Ingham County Treasurer (ex officio) as Chair of the Board of Directors; and

WHEREAS, Section 3.02 of the Intergovernmental Agreement requires the Board to adopt articles of incorporation at its initial meeting;

THEREFORE BE IT RESOLVED, that the Authority approves the proposed Articles of Incorporation provided by the County Attorney; and

BE IT FURTHER RESOLVED, that the Chair is authorized to sign the Articles of Incorporation (Exhibit 1).

Chair reported that an accounting position is being created in the Treasurer's office to assist with cost accounting for foreclosed parcels and also the Land Bank. Additional cost to be covered by fee revenue.

Chair also discussed future Land Bank Executive Director/Controller. Chief Deputy Treasurer Ruttan is retiring mid year 2006, but would be interested in working under contract with Land Bank. This would bring a very skilled employee to Land Bank and assist with transition within Treasury by keeping resource available. Will Budget for position for 2006.

RESOLUTION IN SUPPORT OF A TRANSFER OF INVENTORIED PROPERTIES FROM THE STATE LAND BANK FAST TRACK AUTHORITY TO THE INGHAM COUNTY LAND BANK

RESOLUTION #05-03

WHEREAS, the Land Bank Fast Track Act, 2003 PA 258, being MCL 124.751 et seq., ("the Act") establishes the State Land Bank Fast Track Authority; and

WHEREAS, the Act allows a foreclosing governmental unit, such as the Ingham County Treasurer, to enter into an intergovernmental agreement with the State Land Bank Fast Track Authority providing for the exercise of the powers, duties, functions, and responsibilities of an authority under the Act, and for the creation of a County Land Bank Fast Track Authority (the "Authority") to exercise those functions; and

WHEREAS, the Ingham County Treasurer, with Ingham County Board of Commissioners approval, has entered into such an intergovernmental agreement under the Act; and

WHEREAS, there are currently 19 tax foreclosed parcels in the State Authority inventory and are likely to be more from the 2005 foreclosure process; and

WHEREAS, the County Authority was created to resolve the many issues surrounding the foreclosure of properties in Ingham County; and

WHEREAS, the County Authority can more effectively resolve neighborhood and local governmental concerns regarding the disposition of Land Bank properties;

THEREFORE BE IT RESOLVED, that the Authority authorizes its Chairperson to enter into negotiations with the State Authority for the transfer of certain parcels in the inventory of the State Authority to the County Authority;

AND BE IT FURTHER RESOLVED, that the County Authority Attorney and Chair shall keep the County Authority apprised of negotiations with the State Authority.

MOVED BY DELEON, SUPPORTED BY COPEDGE, TO APPROVE AMENDED RESOLUTION.

Chair discussed the State Land Bank inventory of properties from prior year foreclosures. Most parcels are bits and pieces that are best attached to adjoining parcels. The best way to make corrections is through the Land Bank. A few of the parcels may have environmental contamination. Chair would like authority to work with State staff to acquire parcels that make sense for both Authorities. These discussions will include any current year parcels received by State Authority.
